Update on revision of the Carcinogen and Mutagen Directive – CMD

The proposal of the revision of the CMD will be tabled this week (probably on Friday) with high chances that crystalline silica (RCS) is in the list. Enclosed a fact sheet provided by IMA Europe with highlighted the demands from the mineral industries in order to avoid a too stringent application of the directive to our products.

Once the proposal is officially on the table, we will discuss the next steps of our strategy.
